 thereof hereby make publicke declare this to be my last will & Testament looking all other wills by me formerly made first and principally I have committed my soul
 into the merciful hands of Almighty God my Maker Saviour & Redeemer And my body I commit to the earth from whence it was taken and to be buried at the discretion of
 my Executors hereafter named whosoever it shall please God to call me And as for my worldly estate that it hath pleased Almighty God to lend me I do hereby
 devise thereof as followeth Item I give and bequeath unto Mary my well beloved wife All that my substance Messuages or Tenements wherewith I was well furnished
 within the Parish of Honham aforesaid with all the yards Gardens Orchards Trees outhouses & Buildings thereto belonging And also all those my two eldest or younger of Chables
 Land & Pasture this into endowments & belonging with their appertinances to be & remaine to the purpose use & behoofe of the said Mary my wife & her Assignes
 during the course of her natural life And from and after her decease to be and remaine to the purpose use & behoofe of my son Daniell Rivo and John Spiers
 Spiers of Widdon in the County of Essex yeoman and of their heirs and Assignes forever Upon condition that they the said Daniell Rivo and John Spiers
 their heirs Executors Administrators or Assignes shall & do well & truly pay or cause to be paid unto Ann Spiers the wife of the said John Spiers for the
 of ffive poundes of Lawfull Money of England within two yeeres next after the decease of the said Mary my wife the said Ann Spiers her heirs Executors or Assignes
 Receipt thereof and her Acquittances shall be their discharge And also that they the said Daniell Rivo and John Spiers their heirs Executors Administrators or Assignes
 shall & do well & truly pay or cause to be paid unto my son Mary Rivo the full summe of ffive poundes of Lawfull Money of England within three yeeres
 next after the decease of Mary my wife being demanded and her Acquittances shall be their discharge And also that they the said Daniell Rivo John Spiers their heirs
 or Assignes shall & do well & truly pay or cause to be paid unto my son Richard Rivo the full & whole summe of ffive poundes of Lawfull Money of England within
 four yeeres next after the decease of Mary my wife being demanded her heirs Executors Administrators or Assignes shall & do well & truly pay or cause to be paid
 Rivo John Spiers their heirs Executors Administrators or Assignes shall & do well & truly pay or cause to be paid unto my son William Rivo the full & whole summe of
 ffive poundes of Lawfull Money of England within ffive yeeres next after the decease of Mary my wife being demanded her heirs Executors Administrators or Assignes
 them for the Receipt thereof And also that they the said Daniell Rivo John Spiers shall & do well & truly pay or cause to be paid unto my son Richard Woodward
 the summe of ffive poundes of Lawfull Money of England within six yeeres next after the decease of Mary my wife being demanded her heirs Executors Administrators or Assignes
 an Acquittance for the Receipt thereof And also that they the said Daniell Rivo John Spiers their heirs Executors Administrators or Assignes shall & do well & truly pay
 or cause to be paid unto the two daughters of my son Anthony Woodward the summe of ffifty Shillings a peece of Lawfull Money of England within seven
 yeeres next after the decease of Mary my wife being demanded their Acquittances shall be their discharge And if in case that them the said Daniell Rivo or the
 said John Spiers shall & do refuse to pay any of the Legacies herein before mentioned according to the tenor & contents Appointed that then my will & mind is
 that at all tymes after such default for non payment thereof the party to whom the Legacy is given shall & may Enter in & recover all the said Messuages & Lands by
 virtue of this my last will & Testament And have & take all the profits thereof untill hee or shee Legatee or Legatee be fully paid out without the least
 contradiction of the said Daniell Rivo or John Spiers or either of them their heirs or Assignes Item I give & bequeath unto my son Anthony Woodward
 the summe of one Shilling of Lawfull Money of England to be paid unto him by my Executors within one Month next after my decease being demanded All
 the rest of my movable Goods & Chattels whatsoever that I shall have at the tyme of my decease I do hereby give & bequeath them all unto Mary my wife
 towards the payment of my debts & Legacies And I do hereby make & containe the said Mary my wife sole Executrix of this my last will & Testament In
 witness whereof I the said Daniell Humond son have hereunto sett to my hand & Seale the day & yeere first above written
