

In the name of God Amen the first day of August in the second years of the Reigne of our Sovereigne Lord & Lady William & Mary by the grace of God of England Scotland France & Ireland King & Queen Defender of the faith or Church of Rome I James Profland of Honham in the County of Essex widder beinge moved out of yourt mind & memorye praied to vnto Almightye God for the fauour yett - knowinge that my tyme here vpon earth is but short and my life vncertaine I doo therefore herebye make publish and declare this to be my last will & Testament in manner of forme followinge, vnto firste principallye I giue and Comend my soule into the Mercifull hande of Almightye God my Maker Saviour and Reddomeer And my Bodye I Comitt to the earth from whence it was taken And to be buriede at the discretion of my Executors hereafter named whosoeuer it shall please the Lord to send me And as for the worldlye Estates that it hath pleased the Lord to send me I doo herebye dispose thereof ad felloweth, Item I giue and bequeath vnto Lewis Profland my sonne vnto the somme of Barzilia Profland my sonne dowrye my Joynt Reddome standinge in the Parke vnto the house wherin I now dwell And also the South & North Bankes standinge in the field to be left for him this house by my Executors after my decease Item I giue and bequeath vnto John Profland Lewis Profland George Profland and Thomas Profland my sonne And to James Pumphret the wife of Robert Pumphret my daughtere All these my Movable goodes of household stuffe and all the somme that I shall haue at the tyme of my decease And all the wood all the wood and all the Trees or brayns that shall be growinge in or vpon anye vnlowed and equallye parted bye fower other or thre or more whom they shall make choise of to part them vnto one weeke next after my decease And when that they are parted bye fure other as they shall thinke to part them Then my will & minde is that my daughtere James Pumphret shall take first that part which she shall make choise of And then my fower sonne aforesaid John Profland Lewis Profland George Profland & Thomas Profland to take their parts And further my will & minde is that everye one of my sonne funerall charges for the probate of this my last will & Testament Item I giue and bequeath vnto George Profland & Thomas Profland by them called in and to receive the Money vnto Sixe Monthes next after my decease And then all that Money to be equallye parted before his Exors or Legors shall become due and payable as aforesaid That then my will & minde is that his part shall be equallye parted vnto Lewis Profland George Profland & Thomas Profland my sonne James Pumphret my daughtere And further my will and minde is that all my writinge Apperrell both Linning & Woollen shall be divided amongst all my children And that my daughtere James Pumphret shall part them as she shall thinke fitt And I doo herebye nominate and ordaine my lovinge sonne George Profland and Thomas Profland to be my Executors of this my last will & Testament Reuokinge & Disannullinge all former wills by me formerlye made In witness whereof I the said James Profland haue here vnto sett to my hande & Seale the daye & year firste abovesaiden And I doo further desire my lovinge sonne in Law Robert Pumphret to be fuzorviser of this my last will & Testament to see all thingse performed accordinge to the true intent & meaninge thereof:
